- Yog koj tsis muaj daim ntawv yuav tshuaj los ntawm kws tshuaj, koj tsuas yuav tau
 - o 3.6 grams ib hnuv
 - o 7.5 grams ib hlis
 - o 2 pob tshuaj ib zaug
- Ib hnuv tsis pub yuav tshaj:
 - o 120 lub tshuaj ib hnuv
 - o 30 lub tshuaj uas kav 12 teev ib hnuv
 - o 15 lub tshuaj uas kav 24 teev ib hnuv
